SUNSET HARBOR YACHT CLUB CONDITIONS AND ELIGIBILITY FOR MEMBERSHIP

The Club shall have the absolute right to designate, from time to time, persons who are eligible for membership and who shall have the right to use any and all of the facilities of the Club, upon such terms and conditions as determined from time to time by the Club.

Eligibility for membership in Sunset Harbor Yacht Club shall not be based on sex, race, color, religion or national origin.

This application is for membership in and thereby to enjoy the Club privileges of Sunset Harbor Yacht Club in Daytona Beach. This application will not be acted upon unless fully completed, executed and accompanied by a check for payment of the required annual dues, initiation fee and applicable taxes.

Applicant agrees that the exercise of any and all membership rights are subject to all the by-laws, rules and regulations of the Club, whether enacted currently or in the future. Applicant agrees that the Club retains the right to enact, rescind and amend the by-laws and the rules and regulations governing membership rights and the use of the Club facilities.

Applicant understands that membership is not an investment in the Club nor does it provide an equity ownership in the Club or the Club's facilities.

Applicant acknowledges that use of the Club's facilities may be restricted from time to time according to season and that specific use changes may vary from time to time according to special events.

Applicant covenants and agrees to release, waive, indemnify and hold harmless the Club and its owners, directors, officers, employees, representatives, affiliates and agents, from any and all loss, cost, claim, injury, damage, action or liability sustained or incurred by him/her or his/her family or guests, resulting from any act or omission of any director, officer, employee, representative, affiliate or agent of the Club or arising out of or incident to membership in the Club and/or use of the Club's facilities.

Applicant acknowledges that member categories are non-transferable except for special conditions and that initiation fee differences may be paid. Initiation fees and dues are non-refundable.

Applicant agrees to be responsible for all charges incurred which shall be due and payable no later than ten (10) days from the date of the monthly statement. All unpaid charges shall accrue interest at 1.50% per month, beginning 30 days following billing, until paid. All costs and expenses incurred by the Club in the collection of any amounts not paid when due, including, but not limited to court costs and attorney's fees, whether at the trial level or an appeal, shall be charged to applicant, and shall be due and payable upon demand.

Applications shall be for one of the following categories with initiation fees and dues listed.

Intermediate – under the age of 40

Corporate (Min. of 3, Max. of 5)

Non-resident & spouse

(Outside Volusia & Flagler Counties)

Initiation fee will accompany application form.

The initiation fee is a one-time charge.
